#### **Emergency Vehicle Operations**

This presentation will provide a pictorial review of emergency vehicle accidents and their causative factors. Subjects covered include DUI, railroad safety, response policies, intersection safety, rural apparatus driving, leadership and maintenance. As we review the anatomy of a rollover accident we will discuss tactics to consider when the apparatus leaves the roadway on a curve and successful ways in which to recover.







#### **Aerial Ladder Placement and Operation**

Training will be conducted on the proper placement and operation of aerial devices. Topics covered will be the characteristics and operating features of rear-mount, platform and quint apparatus. Special emphasis will be made on truck company placement for various types of occupancies, rescue and life safety strategies and tactical work of quint apparatus. Finally, strategies and tactics will be discussed in the operation and proper positioning of aerial ladders and to be successfully deployed at the scene of fire and technical rescues. This will allow operators to maximize the use of the expensive yet under utilized pieces of apparatus.
